GOLD WEST SECURITY DEPOSIT IS ONE AND A HALF TIMES THE COST OF FIRST MONTHS RENT PER UNIT. Example : If rent is \$750 then the security deposit will be \$1,125 If rent is \$625 then the security deposit will be \$937.50. For those with pets or if there are multiple applicants and one or more applicants does not meet the credit score and rent is \$750 then the security deposit will be \$1,500. If rent is \$625 then the security deposit will be \$1,250. All residents are required to provide renters insurance with up to \$100,000 coverage. There is a \$200 holding fee to take a rental off the market for a period of 15 days and hold while an applicants application is pending. This holding fee is non-refundable after 72 hours of approval. Should the applicant need additional time past the 15 days then an additional non-refundable deposit of \$400 is required for no more than an additional 15 days. If applicant moves into the unit then all monies will be applied to the security deposit. There is a \$10 deposit on Gate cards and \$20 deposit on the Remotes. Basic Cable is provided at \$29 per month and is in addition to the monthly rent. A non-refundable application fee of \$20 per adult will be paid up front. Smoking is not permitted in any of our rental units. GOLD WEST OFFERS COURTESY WIFI THROUGHOUT THE COMMUNITY. Please see the move-in criteria on the reverse side of this document and Pre-conditions to lease.

The following are the criteria that we follow with all applications:

- You must have a credit score of 620 or higher and management may require utility bills to be paid in full in order to qualify
 - All applicant(s) who are 18 years or older will be added to the lease
- If there are multiple applicants and one applicant meets the credit score of 620 or higher and the other applicant(s) have no credit score or their score is below 620 but meets the other qualifications (as listed below) they may be approved as a tenant however a higher deposit of 2 times the rent will be required.
- If applicant(s) do not have a credit score but meet all other qualifications (as listed below) they may be approved as a tenant however a higher deposit of 2 times the rent will be required.
 - If applicant(s) have no credit but meet all other qualifications (as listed below) they will be required to bring in 2 current bills from previous address (ie. Cell phone, credit card, utility, etc.)
- Income must be 2 ½ times the rent.
 - If one applicant has no credit score or score is below 620, the applicant that meets the score of 620 or higher will be used to qualify and their income has to be used as a combined income of all applicants in order to qualify as well and must meet the other qualifications as listed below
- Proof of verifiable income (last 3 months pay stubs and w-2 or 1099 if self-employed).
 - If currently working need 1st two pages of tax returns and if self-employed need tax return including Schedule C and any other Schedules that pertain.
 - Applicant must have been on the job for a period of one (1) year
 - If applicant has been on job less than one (1) year the security deposit will be twice the rent.
 - Three (3) months of bank statements are required
- No Evictions
- Foreclosures dated after December 2012 are automatic denial.
- No Felonies
- Must have positive rental history.
 - If you are a first time renter or are currently living with parents a higher deposit of 2 times the rent will be required.
- Bankruptcies will be accepted however from the date of the bankruptcy there must be no adverse credit within 1 year from the date of discharge of the bankruptcy
- No co-signers
- No Section 8
- Pets are allowed (subject to management approval). For those that have pets the Security Deposit will be twice the rent. There is also a pet rent charge of \$35.00 per month. **(RENTERS ONLY)**
 - Only 2 pets are allowed per household. Additional pets may be allowed upon management approval. Additional pet larger pet deposit and pet rent may be required.
- With regards to pets please note some breeds are not accepted.
- A background check which includes a criminal check on every prospective tenant who is an adult.
- Any misrepresentation on the application discovered prior or after the application or the lease agreement is signed will be probable cause for denial or dismissal of the lease.
- Deposit must equal 1 ½ months' rent unless otherwise stated. **(RENTERS ONLY)**
- 2 Forms of Identification are required
- An additional fee may be charged if employment must be verified via an outside source (i.e. The Work Place)
- Renters insurance in the amount of \$100,000 is required and must be provided to management within 30 days of moving into Gold West.
